I. <u>ADMINISTRATION</u>

A. Chair's Introductions & Announcements

The Chair called the meeting to order at 10:35 AM.

B. Review of Antitrust & Meeting Guidelines

The purpose of antitrust laws is to preserve economic competition in the marketplace by prohibiting, among other things, unreasonable restraints of trade. In ARESCA activities, it is important to recognize that participants often represent competitive interests. Antitrust laws require that all competition be open and unrestricted.

It is ARESCA's policy, and the policy of each of its committees and subcommittees, to conduct all business and activity openly and transparently, and in full compliance with international, federal and state antitrust and competition laws.

C. Quorum Determination and Roster Review

The committee consists of eighteen (18) voting members, 12-manufacturers, 5-CBs/TLs, and 1-General. At least a majority of the voting members need to be present to constitute a quorum to establish a duly constituted meeting for the purpose of conducting business.

D. Review/Approve Agenda (Chair)

The Chair reviewed the agenda for the meeting, and it was approved.

E. Acceptance of Previous Minutes

The minutes of the October 9, 2017 meeting were circulated to members on October 17 for review and approval. Members were advised that if no

comments were received November 1, the minutes would be automatically approved. No comments or corrections were received.

III. <u>FINANCE</u>

A. TREASURER'S REPORT (Gabe Alsenas)

- 1. Proposal for 2018 budget
 - a. Membership dues were raised \$300 per organization to offset ANSI CA system fee.
 - b. Failed to achieve quorum on 2 letter ballots.
 - c. Robert Stewart expressed concerns that IECRE is not yet functional and there is no demand for certificates. There is a lot more demand for MEASNET calibration reports instead of IECRE.
 - d. This is consistent with discussion in Feldkirch by both WE-OMC and REMC. Emphasis on promotion of system and generating revenue.
 - e. Wally Ebner has notified AIG clients that IECRE certification will be highly preferred if not required. Other stakeholders have been encouraged to issue similar statements.
 - f. Sandy reported on recent activities in WG004 (Promotion). Goal is to publish promotional materials, but funding not available until beginning of 2018. It is up to each participant to communicate the value proposition to clients and other stakeholders.
 - g. Test labs have made most progress, but CBs are catching up. OEMs and End Users have to agree that IECRE has value and is worth the cost. Ultimately End Users have to drive demand.
 - h. Test report template is seen as too difficult to implement and there are concerns about what data will be searchable in the IEC database. Suggestions that we emulate best practices from IECEE, and that fix rules so they achieve our needs. This was discussed in Feldkirch (refer to Decision 13/2017), but we do not feel it was resolved. The USNC should consider making a proposal to simplify things and encourage use of IECRE logo.

2. Ballot for 2018 budget

This is the last opportunity to approve the 2018 Budget & Fee Structure. Bob called for a vote. Sandy seconded. Vote was 13-0 in favor.

ACTION: George to notify CAPCC of approval of budget and fee structure.

II. SYSTEM AND SECTOR ACTIVITIES

A. REMC (Bob Sherwin)

- 1. Minutes of the WE-OMC Meeting 6-7 Nov 2017 in Feldkirch, Austria were distributed previously.
- 2. Sandy reviewed the highlights (promotion and finance). Late proposal from Denmark was discussed but no decisions were taken.
- 3. Discussions are ongoing in WG006, but progress is slow.
- 4. Steve Margis described funding of IECEE system. Difficult to relate directly. Revenue from non-members (surcharge fees) are significant, as well as sales of test report templates. Very small fees are charged for certificates, but volume is tens of thousands. Expenses are very similar to IECRE ("non-negotiable", but we should continue trying).
